**RECOMMENDATION:**

**BACKGROUND:**

Unit 1163 was a 2007 Ford Taurus that was in an accident, totaling the vehicle. 1163 was in the budget to be replaced in 2018. Because it was near the end of its life, we have already collected enough funds to replace it now, without waiting for the insurance funds. Due to other items coming in under budget, there is sufficient budget for this replacement as well.
