RECOMMENDATION:

A resolution to award Bid #22-17 and authorize the purchase of lights, fixtures, and poles for varying unit prices from Premier Lighting Group as needed through the end of 2022.

BACKGROUND:

The City network of sidewalks and trails provide a safe and efficient means of active transportation. Each year funding is allocated for continuing the enhancement of this growing system. Currently approximately 20 miles of trails have energy efficient LED lighting.

DISCUSSION:

Staff recommends awarding this bid to Premier Lighting Group in order to match the design of existing lights, fixtures, and poles.

BUDGET/STAFF IMPACT:

Funds for the acquisition of these materials have been budgeted in Street, Sales Tax Capital Improvement Funds, and Streets Project 2019 Bonds funds.
